# FORFEITURE OF FREE LAWN SERVICE

John: The Association currently offers free (front lawn) mowing services to its Members. He recommended that this benefit be forfeited to those who continuously violate the rules of the Association i.e., property maintenance, parking, easement encroachment, dumping, fireworks, unlicensed, unregistered, inoperable vehicles, pet nuisances, etc. The definition of a habitual offender would require further review; however, he would like to proceed with the introduction of this concept in the newsletter. The suspension of the free lawn service benefit to a habitual offender would be decided by vote of 4 out of 8 Board Members.

## PROPERTY OWNER VIOLATIONS

John: Property owner, Manny Rubies, 5642 Kimberton Way, installed a backyard fence that is encroaching on the easement. Rubies never submitted a completed Architectural Request Form to the Association for approval prior to the fence installation which is in violation of Article X, Architectural Control. He has repeatedly refused to remove the fencing thus creating a nuisance consisting of the obstruction of adequate easement access for safety and welfare of his neighbors and the ability of the Association to properly maintain the public utilities. Per Article XIV, General Provisions, Section 5. Remedy for Violation, the Association has the right to abate or remove the violation at the expense of the owner whereby the fencing will be removed without being deemed a trespass. Motion to remove the fencing located at 5642 Kimberton that is encroaching on the easement.

#### **OFFICERS AND THEIR DUTIES**

John: It was recommended that Barbara Ausanio fill the position as Secretary in order to keep the minutes of all meetings. The office of Secretary and Treasurer is currently held by Bryan Stanley. Barbara asked if she would have to forfeit her current title as Vice President should she accept that position. The answer was yes, per Article XI, Officer and their Duties, Section 7, Multiple Offices. Only the offices of Secretary and Treasure may be held by the same person. No person shall simultaneously hold more than one or any of the other offices except in the case of special offices created pursuant to Section 4 of this Article. Barbara Ausanio declined the position. Subsequently, Javier Torres, accepted the responsibilities associated the role and title of Secretary.
